### 2.Scope

2.1 This document applies for use of

- Use of IQAS Symbol for Testing and Calibration CAB's as per ISO/IEC 17025, Medical Testing CAB's as per ISO 15189, PTP CAB's as per ISO/IEC 17043 and RMP CAB's as per ISO 17034, accredited by IQAS
- Use of IQAS Accredited CAB Combined ILAC MRA Mark by Testing, Calibration and Medical CAB's.

Note:- a) Use of IQAS symbol is voluntary, however IQAS encourages the use of IQAS symbol.

b) Use of the IQAS Accredited CAB Combined ILAC MRA Mark for IQAS accredited CAB's is voluntary, however its use is subject to agreement between IQAS accredited CAB and IQAS as per Annexure – 1 of this document.

### 7. Instructions for use of IQAS Symbol by CABs claiming accreditation status

**7.1** The IQAS accredited CABs shall use the IQAS symbol, downloaded from the IQAS email sent to CABs to claim the accreditation for the scope accredited by IQAS or from IQAS website [www.iqas.co.in](http://www.iqas.co.in) The IQAS symbol, of various sizes, will be provided by IQAS to the accredited CABs on award of accreditation certificate and scope.

**7.2.1** CAB's may use color or black and white IQAS symbol on the calibration, testing, medical testing, PTP and RMP certificate. The color of black and white symbol should be reproduced without any change in color as available on IQAS website.

**7.2.2** The IQAS symbol which can fit on the upper corner, right or left of the calibration/testing, medical testing, PTP and RMP certificate can be used by the accredited CABs.

**7.2.3** The CABs may use the IQAS symbol on the electronic documents. IQAS symbol shall bear the accreditation certificate number just below the IQAS symbol. In case, any CAB is accredited for more than one field, for example a CAB accredited under testing and calibration field, then both symbols used for testing and calibration activities will bear the testing and calibration certificate number just below the IQAS symbol.

Also, when CAB wants to use the IQAS symbol for marketing and promotional activity then both the symbol should be used separately along with certificate no. for the testing and calibration purpose.

**7.3** The CABs shall use the IQAS symbol only for the accredited scope

7.3.1 The IQAS symbol shall not be used by a CAB's external service providers that are not accredited by IQAS.

7.3.2 The IQAS symbol shall be used by an accredited CAB only under the name or the registered trade name of the legal entity in which it holds accreditation.

**7.4** The accredited CABs may use IQAS symbol for advertising and promotion purposes.

7.4.1 An accredited CAB and its parent, subsidiaries or sister companies (who are also accredited by IQAS) may wish to incorporate in publicity and/or advertising material, statements concerning the CAB's accreditation.

Materials may include:

- website(s);
- publicity and advertising material.
- brochures and organisation publications;
- technical literature.
- business reports;
- quotations or proposals for conformity assessment activity.

The CABs shall take care that use of IQAS symbol shall not mislead about the accreditation status of the CAB.

**7.5** The franchisee or any other CABs which is using the results of accredited CAB shall not use the IQAS symbol on behalf of accredited CABs.

**7.6** Immediately upon suspension, debar, withdrawal and a break in accreditation cycle, the CAB shall discontinue the use of IQAS symbol and cease to make reference to accreditation status in reports, certificates, promotional material, letterhead, internet websites etc.

**7.7** IQAS Symbol shall not be used by applicant CABs.

**7.8** IQAS symbol shall not be placed on the products or items which have been subjected to conformity assessment (except on calibration labels).

## **8 Calibration Labels on equipment**

8.1 IQAS accredited calibration CABs can use the IQAS symbol in calibration labels which are attached to the item of equipment calibrated by IQAS accredited CAB.

8.2 Calibration labels containing IQAS symbol shall not give the impression that IQAS has approved or calibrated the equipment.

8.3 The calibration label usually includes the following information:

- a) the name of the accredited calibration CAB and its accreditation number
- b) equipment identification
- c) date of current calibration
- d) cross reference to the calibration certificate issued in respect of the calibration

Calibration labels containing the accreditation symbol shall only be used for the equipment which have been calibrated using calibration methods covered by IQAS accredited scope of the accredited calibration CAB.

### **9 Reporting results not covered by the scope of accreditation**

9.1 In case the conformity assessment activities are not covered in the accredited scope or if the scope of accreditation is reduced, the CABs shall mention or identify the same by putting an Asterix '\*' mark on that result(s) and it shall be clearly mentioned in the certificate that Asterix marked result(s) is not covered under IQAS accreditation.

9.2 There shall be nothing in any test report or calibration certificate or in any attachments or other materials that implies, or may lead any user of the results or any interested party to believe that the conformity assessment activity is covered by the scope of accreditation when it is not.

10.2 Electronic reproduction of “IQAS Symbol” is permitted provided that the requirements of this document are met, integrity of IQAS symbol is maintained and distortion of graphic is avoided.

10.3 IQAS accredited CABs (Testing, Calibration, Medical testing, PTP and RMP CAB's) are entitled to use IQAS Symbol under valid accreditation status.

10.4 IQAS accredited CAB's can use “IQAS Accredited CAB Combined ILAC MRA Mark” for Testing, Calibration and Medical CAB's subject to agreement between IQAS and IQAS accredited CAB as per Annexure – 1 of this document.

10.5 IQAS Accredited CAB combined ILAC MRA mark shall be positioned such that it is not combined with any other logo / symbol / mark. In the IQAS combined ILAC MRA mark, the ILAC MRA Mark shall be positioned such that the IQAS symbol shall be on right side of the ILAC MRA Mark, but shall appear in close proximity to each other.

10.6 “IQAS Accredited CAB Combined ILAC MRA Mark” shall be reproduced in black and white color only. Embossed, relief, or die-stamped versions are allowable.

10.7 IQAS symbol and/or ILAC MRA Mark shall always be used in its original, designed proportions. As a general guideline, the height, should be within approximately 5% of the size of the ILAC MRA Mark.

10.8 IQAS symbol and/or ILAC MRA Mark shall not be distorted or stretched in any way.

10.9 IQAS symbol and/or ILAC MRA Mark shall not appear in size that is unreadable.

10.10 ILAC MRA mark shall be maintained in similar proportions to the IQAS symbol (within the Accredited CAB Combined ILAC MRA Mark).

10.11 IQAS symbol and/or ILAC MRA Mark shall only be used in its normal horizontal orientation and not be rotated.

10.12 IQAS symbol and/or ILAC MRA Mark shall be used on a background that will not impede readability.

10.13 IQAS symbol and/or ILAC MRA Mark photocopies from other documents shall not be used. It should be based on original artwork to ensure high quality production.
